- Postprandial glucose level is a screening test for Diabetes Mellitus
- $\bullet \quad \text{If glucose level is $>$140 \text{ mg/dL}$ and $<$200 \text{ mg/dL}$, then GTT (glucose tolerance test) is advised.}$
- If level after 2 hours = >200 mg/dL diabetes mellitus is confirmed.
- · Advise HbA1c for further evaluation.
